There is no need to spend money to patch 100' of the alley, when it needs to be fully redone, and its constant patching. There is no drainage, there is dirt, potholes and all that creates not only rotten water, attracts mosquitos but causes health issues for our two houses. When we had gate open my 4yo was splashed with water and dirt, so All other alleys have been remodeled but not ours, why? Its makes no sense. PLEASE PLEASE PLEASE fund and approve it to fix it, all other alley in our areas were fixed.

I came from Ukraine and have a lot of love for USA, but alley reminds me condition of roads in Ukraine if not worse, I lived through Chernobil and my health is very important to me to me and I don't want to have complication or any infection because someone didn't fix it.

Here is what I see wrong with alley, I also talked to representatives from myla311 and they agreed that road needs to be fully redone including doing proper drainage and they fully aware of the situation.

1. Its in a bad condition, there is lots of pot holes and they very deep.

2. it created dust/dirt that goes to our property, and my little one who is 4 year old and 15 year old been having none stop allergies

3. those holes collect water and all insect go there and to our house/yard, there is also tiger mosquito that we seeing now present that can transmit sickness

Dear General Manager Jimmy Kim, Assistant General Manager Brenda Aguirre, and the entire Board of Recreation & Parks Commissioners:

I want to bring a few facts today to your attention after finally receiving documents requested nearly 2 years ago from Councilmember Raman through a Public Records Act request.

Firstly, the Ambassador Program is an empty promise from Councilmember Raman. It was not going to materialize at all until the RAP Board wisely conditioned the Riverside Bridge Home shelter lease renewal on the implementation of an Ambassador Program. Eight months after Rec and Parks required one, there is still no functioning Ambassador Program for the Riverside Drive Bridge Home in south Griffith Park, leaving the chronic safety and mental health issues unaddressed. Public records demonstrate there was never any money which could have been spent for the CD4-promised Ambassador Program.

As of December 31, 2024, Raman's office paid \$42,000 out of her discretionary fund to an organization Councilmember Raman founded in 2018, SELAH, under the guise of an Ambassador Program. SELAH has historically and currently continues to engage in limited volunteer work such as distributing toiletries, coffee, donuts, and clothing on Griffith Park parkland for 2 hours, one Sunday per month (see attached screenshot of their scope of work from SELAH website) and three hours on Saturdays at a local church. SELAH has no documented experience providing security or mental health services, the two community concerns that Councilmember Raman promised to address with the Ambassador Program. The scope of work and performance requirements for SELAH to act as Ambassadors were never defined for City Council and are absent in Councilmember Raman's original motions to pay SELAH. No contract between CD4 and SELAH has been provided, though the payment was executed (see attached proof of check issued to SELAH in

December 2024 and cashed by Executive Director Sarah Reyes). Additionally, SELAH appears to be working for CD4 on parkland without any park permits.

Councilmember Raman ignored over 4000 known and documented public health and safety incidents in south Griffith Park (MRSA outbreak, rapes, assaults, thefts, vandalism, and more), which she learned of in May 2023 as the community continued to experience these problems. Rec & Parks' and the broader community's safety and security interests were and continue to be ignored by Councilmember Raman. Additionally, based on an email between Patrick Siggins, Homelessness Director for CD4 and Councilmember Raman, the internally defined scope of work for the Ambassador Program was "event coordination" and further support for PATH as shelter operator. There was no consideration for added security or safety around the exterior of Bridge Home shelter in south Griffith Park, as was represented to the community since December 2023 by CD4. See attached email exchange attached as proof. No wonder it took 2 years and a lawsuit to get this information from Councilmember Raman.

To the best of my research, there are no performance criteria defined or contract evident between SELAH and Council District 4 for an Ambassador Program, which exposes RAP to liability and leaves south Griffith Park unprotected. With another Ambassador Program report coming due from CD4 (February 20, 2025), the RAP Commission has an opportunity to hold the Councilmember accountable. The Commission may request the contract, scope of work, and performance requirements, and gain an understanding of how the Ambassador Program is providing enhanced safety and addressing mental health issues around the shelter, per the Councilmember's original promise. The BCommission Board may also consider reaching out to Sarah Reyes, SELAH's Executive Director and asking for any co tracts from City Attorney Andrew Said who was of counsel in this scheme.

Equally important, as a vendor operating on parkland, why is SELAH not required to have a permit to operate in the park like every other vendor in Griffith Park?

The Ambassador Program was a contrived circumvention from Councilmember Raman, as seen in the email exchanges between her and her staff, where she and her team and her Director of Homelessness Patrick Siggins, minimize the massive health and security issues experienced outside the Bridge Home. Councilmember RamanCouncilmember Raman has continually ignored requests by the community to place a special enforcement zone or added security around the shelter exterior, which is the existing City remedy for these issues. Gangs and chronic homeless flock to the Bridge Home shelter, many for the freely available drugs, free toiletries, and stolen goods, free toiletries and stolen goods that create an atmosphere that further ruins South Griffith Park and the surrounding community.

Rec & Parks and the community have been lied to by Councilmember Raman about the Ambassador Program. Instead of leveraging existing City processes, the elected Councilmember passed money to her nonprofit organization with no clear scope of work or accountability for an Ambassador Program to protect the park, the community,or the shelter residents while opening RAP to serious risk.

Secondly, the CAO report of December 19, 2024 and the previously forwarded analysis of the report, highlights the woefully inadequate permanent housing placement of Riverside Bridge Home shelter

clients (termed "throughput" by Councilmember Raman, as though these PEOPLE are livestock). At 8% permanent placement from this shelter, the rate is substantially below LAHSA's published 40% target for permanent placement from interim shelters, and it is also below LAHSA's current City average of 12.5%. Per City Controller Meija's audit and the County Auditor-Controller reports, LAHSA is gravely deficient in fulfilling its mission. However, that is no reason for the independently functioning Bridge Home shelter in Griffith Park to follow suit. Yet, that is the reality, with 92% of the people stuck there for years, unable to transition.

My worst fears have been confirmed - people in the shelter are being warehoused. I now understand why so many are using various drugs and committing crimes around the area. The shelter in Griffith Park is a manifestation of a citywide broken system where nonprofits profit while the unhoused suffer and are unable to move on in their lives. No matter the how public funds are expended, the lack of accountability and transparency means little if funds actually do not go directly to help people in crisis.

At this point, absent an effective Ambassador Program and the severe underperformance of Bridge Home shelter shown in the CAO report of December 19, 2024, the community is asking to have the two use conditions that were set by the RAP Board for lease renewal enforced and to start planning to not renew the lease. We have a dysfunctional shelter without program rules sitting on parkland with very minimal security.

There exists an immediate urgency, as it will take time to find placement for the remaining clients before closure. We need to start now to transition these folks off parkland to ensure they have a place to stay.

It is long past time to house the people in the shelter and close it by July 2025.

Please let the community know how we can work with the RAP Board to start this process. The favor of a reply to this letter is greatly appreciated in advance.

Our community looks forward to seeing you all on December 20, 2025 at 9am at El Sereno Recreation Center (4721 Klamath Street in Los Angeles).



As discussed in our weekly meeting yesterday, here are some bullet points outlining how I was envisioning utilizing SELAH in an official capacity for the Ambassador Program.

Happy to discuss further.

- The area adjacent to ABH Riverside no longer has the level of encampments and unsheltered PEH that generated the initial need for a dedicated small-footprint Ambassador outreach team. We believe we can fulfill the area's proactive & reactive outreach needs 24/7 with existing resources by coordinating with Circle, Ascencia, and, if needed, one of our CD-directed LAHSA teams.Â
- Despite the diminished need for a dedicated outreach team for the area around ABH Riverside, we have promised the community an Ambassador program and we want to fulfill that commitment. However, as the needs of the site have

changed, it seems only responsible for the programming to evolve as well. We envision SELAH creating a more robust, community-based engagement zone at ABH Riverside, both for enrolled ABH participants and PEH who may over time arrive in the area, hosting activities and events that SELAH already has experience coordinating at other locations

- Outreach case management and referrals would still be completed by the existing outreach providers, but SELAH would be funded to do more events, engagement, and advocacy they are already doing and do well, while deepening their supportive role for participants enrolled at Riverside, document support, benefits enrollment, life skills, etc..
- We envision SELAH having a more official role in and around ABH Riverside with regular weekly programming and more frequent and regular participant interaction that we feel would promote participant retention, augment existing case management, increase throughput, and offer a more visible ambassadorstyle zone around the site.
- SELAH could be in regular contact with the outreach teams to support on newly arrived PEH and also help manage some of the ABH-enrolled participant presence outside of the site often misunderstood by neighborhood observers as unsheltered PEH.
- This would be an opportunity to partner with a volunteer-based, community
 organization and dedicate resources for them to augment the existing outreach
 in the area (described above) with an Ambassador-style engagement zone in
 and around ABH Riverside.
- This program has the potential to be stood up quickly with Discretionary Funds while the RFP process for a dedicated Ambassador outreach team continues should that route be deemed necessary.
- As a grassroots, neighborhood organization, SELAH is particularly well-suited to play this role. This would also speak to the concerns of those who express that the local community itself is not engaged enough in the process.
- During recent conversations with SELAH leadership, they have expressed specific interest in being more engaged with our interim housing sites, ABH Riverside, specifically.

On February 20, 2025 I appeared in front of the RAP Board of Commissioners to plead for the non-renewal of the Riverside Drive Bridge Housing contract. By not renewing the contract, removing the temporary structure, and to replace the area with the previously planned Senior Center the Park's property would be better used.

Councilperson Raman has not met her stated goals or the intended purpose for The Bridge Housing Project and Program. The Bridge Housing Project has not met the criteria that RAP Commissioners requested as a minimum to maintain and proceed with the project. Note that the Commission has not received: The Scope of Work addressing its progress, formal materials for The "Ambassador Program" that is to provide assistance, public health and safety in and around the Shelter and surrounding area.

Documentation of the CAO Report shows that the project isn't doing its intended purpose.

Not to use comparisons, but the County of Los Angeles has been doing better as well as some non-profit organizations. The use of their programs and methods should be monitored if there should be progress for the unhoused and in medical need individuals in the Riverside Drive Bridge Housing Project/Program.

CANCEL THE CONTRACT TO RIVERSIDE BRIDGE HOUSING AND BUILD THE LONG AWAITED PLANNED SENIOR CENTER!

Crime in the immediate area due to the draw of the Bridge Home shelter for drugs remains high. Last reported by LAPD, Los Feliz had 40% increase in property crimes this past year. People from the shelter return to Los Feliz to commit crimes. It was reported to police that a previous Bridge Home shelter client returned to the Los Feliz Business District to steal wire while First Responders were occupied working on the Palisades and Eaton Canyon fires.

Random homeless people continue to come to Griffith Park for drugs and sex with shelter residents from MacArthur Park, Hollywood, Downtown LA. **Rec & Parks is the overseer of the largest and greatest park in the nation. Time to manage our Park.**

We need the long promised Community Center, the Mulholland Fountain and the pool!

Please help our community heal the south Griffith Park area and make it safe again.

The community needs more detailed information about the status of the south Griffith Park Master Plan from Rec & Parks that was touted by CD4 during Raman reelection campaign a year ago. It would be appreciated if General Manager Kim could coordinate this with the appropriate RAP staff and get back to us at the March 6, 2025 Board meeting.

Thank you for your hard work managing many disparate issues, and thank you for hearing my 2 minute testimony at El Sereno Park last week.

As you know, in August 2024, you Commissioners required 2 conditions of councilwoman Raman in order to continue leasing the Bridge Housing located (we were told temporarily) on park property on Riverside Drive. You said that if these conditions were not met, you would refuse to continue her lease to the facility.

These conditions HAVE NOT been met, and there NOW need to be the reasonable consequences of non-renewal as you stated.

Condition #1-An accountability report on the success of the shelter. The City Administrator Officer, did a report and stated that over the almost 5 years a mere 8% of the occupants have received permanent housing. (And at the cost of \$3+ million/year). For the occupants, for the community, for the city, and for Griffith Park this EXPERIMENT IS A FAILURE. Raman has exercised no oversight nor accountability of this very expensive facility. Condition #2-An Ambassador program for greater safety. Although told to implement her plan, Raman has not done so, and according to emails obtained, never intended to do so. Instead, her personal non-profit cashed a \$42,000 city check ostensibly to help with security. This non-profit and the money sent to it were never approved by City Council, and in actuality are being used for her promotion such as by sponsoring coffee and donuts at Griffith Park(and done without a permit).

Disregarding your directive to implement an Ambassador program, Raman illegally sent thousands of dollars to her non-profit which is completely incapable of providing security to our neighborhood which has experienced a 300 % increase in crime, multiple fires, and vandalizing of our precious Griffith Park.

PLEASE in good conscience, do not continue to facilitate and support Raman's intransigence and failure of a facility which has attracted criminal elements and terrorized the good people of our neighborhood.

Thank you so much for writing to us, and I have deep empathy for the concerns you raise.

Some of these are issues that our office and the respective departments have already been working on, including improvements in red flag day operations, responses to home burglaries, and Griffith Park maintenance. During this most recent emergency, it was because of our office's work at the Emergency Operations Center that we were able to preemptively close our hillside parks and we worked closely with the Rangers, Rec and Parks, DOT and LAPD to enforce these closures during a time when resources were stretched very thin. We were very grateful for the partnership within the city with these departments, but also recognized that better procedures needed to be in place going forward, both during and outside emergencies.

You've asked about a very broad range of issues - Give us a few days to coordinate some responses and information on the questions you're asking, and we can take it from there!

We are all residents of Los Feliz north of Los Feliz Blvd. We love Griffith Park and Los Feliz and feel that the quality of life here has been impacted of late by an increase in crime, a glut of traffic clogging our narrow streets, homeless living in the park, and most alarmingly, the threat of fire. All of this has contributed to an enormous increase in risk to our safety, to our homes, and to the park itself, as clearly evidenced by the recent fire near the gate to the park at the end of Glendower Road.

We are a close-knit community who all look out for one another and endeavor to preserve the wonderful quality of life here in Los Feliz. This letter and the requests below represent the desires of our community to have the city implement better measures in protect us...

1) RESTRICTING TRAFFIC - It would be beneficial to have cones and a park/city person stationed at Glendower Road during park closures since map services such as Google Maps and Apple Maps mark Glendower Road (a dead end road) and the fire road adjacent to it, as ways into the park. This causes traffic log jams on Glendower and Catalina which would make getting fire trucks up here virtually impossible. And should there be a fire, these traffic log jams would make escape for residents equally impossible and a potentially life threatening hazard.

2) BETTER SIGNAGE — Having large and well-marked signs at key access points to the neighborhood would better inform drivers that Catalina and Glendower Ave are not routes to get to Griffith Park and the Observatory. The number of drivers who are lost trying to get to the Observatory via Glendower and Catalina is constant and burdensome.

3) GOOGLE MAPS CORRECTION - It would have enormous weight if the city vs the local citizens reached out to Google Maps and Apple Maps to correct the error in their routing which directs traffic to the Observatory and Park via the fire road at the end of Glendower

Road. The volume of this traffic increases exponentially whenever the park is closed as well as when there are events at the Greek Theater.

4) POLICE PATROLS - There has been a significant uptick in crimes on Glendower Avenue. A number of homes have been broken into and there has also been an increase in the number of homeless coming north of Los Feliz Blvd looking for homes to squat in, rob, or to sleep in the park. There have been mentally unstable characters screaming expletives and racial slurs at all hours, as well as unsavory types scoping out homes and cars to rob. Having regular patrols by our police force could be helpful to keep crime and would-be criminals at bay. Many of us do have the alarm company, ACS patrolling the area as well and have made them aware of the increasing issues. But our police force carries much more weight and are best trained to handle crime and other issues.

5) ELIMINATE HOMELESS LIVING IN THE PARK - With homelessness on the rise, some individuals have taken to living in the park. This exponentially increases the potential for fire in the park As case in point, the homeless and mentally unwell man who started the fire in the park near Glendower Road, was it turns out, living in the park for some time. One neighbor had called Park Services to complain but nothing was done to remove him. The fire that he started with firecrackers could have been a disaster for both the park and the neighborhood. And then this individual had the gall to come a week later, looking to move back into the spot he lit on fire, but neighbors called the police and he quickly moved on. But who knows if he now decided to camp into another part of the park. How he was not charged with arson is baffling.

Considering the billions of dollars these recent fires have cost the city and citizens, not to mention the enormous heartbreak, we feel it is imperative that the city implement better precautions to safeguard our park and neighborhood. So far, we have been lucky, but like all luck, it never lasts. And so, to this end, we would like to suggest the use of the following...

DRONES & THERMAL CAMERAS- We feel that the park should use drones and rangers to periodically check for homeless encampments. Not the whole park, but the perimeters and areas with the most access. These camping spots can be very hard to spot and in the past, neighbors have reported well-hidden spots where homeless individuals have set up places to reside. Drones are one of the best and most cost tools to cover a lot of ground efficiently. Thermal cameras are another inexpensive tool that rangers and police can be issued that easily enable them to identity people hiding or residing in dense brush. Our park needs to remain a safe place not, become a campground and the people who protect our park need the right tools to be as effective as possible.

6) PARK CLOSURE ON RED FLAG DAYS AS FIRE PREVENTATIVE MEASURE — Whenever there are Red Flag days, we feel that the park should be also closed too. Having the park open during Red Flag days invites the greater potential for fire because of the thousands of people who visit the park every day. What is the point of merely protecting the park from the outside by making the roads more passable to firetrucks, but not do anything to protect the interior of the park itself? The current approach seems like an ineffective halfmeasure that is not maximizing a preventative approach to the very real fire issues that confront this city. In light of the recent devastation to our city where the fires have leveled entire communities, we have been lucky so far that a fire has not ravaged Griffith Park and the surrounding community. But that's all we've been – lucky. It is our hope that we can learn from this recent disaster and better prepare ourselves with preventative measures so that history is not doomed to repeat itself.

In closing, we love our neighborhood and Griffith Park and want them to be safe and we want to preserve the wonderful quality of life both the community and the park provide. Thank you for your consideration of these requests and possible solutions to address the problems at hand that impact all of us.

Summary: Los Feliz residents and neighboring residents experienced anxiety during the recent wildfires along with anxiety over the ever-fluid information regarding openings and closures of Griffith Park and other city facilities. While Red Flag Warnings have always existed, the communication around what these warnings entail, how they are implemented and enforced, and their purpose was severely lacking and caused much confusion in this emergency situation. We agree with the purpose of this Council File in asking for process improvements and recommendations for clearer education and communication. We also emphasize the importance of messaging and education around warnings and closures to be clearly communicated to all employees, especially those who must help enforce warnings to the public. Dear Mr. Reinschmidt and the Golf Division Team,

I am writing to express my deep concern and frustration regarding an ongoing situation at Rancho Park Golf Course that undermines the principles of equitable access to a public recreational facility. Specifically, the Ladies Club has been permitted to reserve *every* daylight tee time on Tuesdays, effectively excluding all other golfers —including senior players like myself who rely on weekday discounts—from accessing the course during those hours. This practice stands in stark contrast to the intended purpose of a public golf course and echoes the challenges that prompted recent reforms in tee time reservations. I urge the Golf Division to address this issue promptly to restore fair access for all golfers.

Rancho Park, as a municipal course operated by the City of Los Angeles Department of Recreation and Parks, should serve the broader public, not cater exclusively to a single group. The current arrangement with the Ladies Club effectively privatizes the course on Tuesdays, leaving no opportunity for other players to book tee times,

even through cancellations. This is particularly galling given the Golf Division's recent efforts to curb tee time monopolization. Not long ago, the prevalence of brokers—many within the Korean community—scooping up desirable slots at Rancho Park and other city courses led to widespread outcry from regular golfers. The introduction of a \$10 non-refundable deposit policy in 2024 was a direct response to that inequity, aimed at deterring such practices and ensuring broader access. Yet, the Ladies Club's blanket reservation of Tuesday tee times replicates the same exclusionary effect, boxing out everyday players who simply wish to enjoy a public resource.

As a senior golfer, this situation impacts me personally and financially. The Golf Division's own policies, as outlined on the LA City Golf Courses website, provide discounted green fees for seniors on weekdays—\$24 for 18 holes at Rancho Park, compared to \$50-\$55 on weekends. However, with Tuesdays entirely unavailable, I and other seniors are denied the opportunity to benefit from these discounts on a day that should, by all rights, be accessible. This not only limits my ability to play but also diminishes the value of the public golfing program that the city promotes.

The Golf Division's Rules, Regulations & Code of Conduct, as established by the Department of Recreation and Parks Board of Commissioners, emphasize fairness and accessibility. While the rules explicitly prohibit "brokering or advertising tee times for resale without express written consent" of the Golf Division, the spirit of this regulation is to prevent any group or individual from monopolizing tee times to the detriment of the public. Furthermore, the Golfer Code of Conduct calls for players to "show the utmost respect and dignity to fellow golfers" and to avoid actions that "damage the character, integrity, good will, property, and community view" of LA City Golf facilities. Allowing the Ladies Club to dominate an entire day's worth of tee times arguably contradicts these principles, as it prioritizes one group over the diverse community of golfers the course is meant to serve.

I recognize that golf clubs, including the Ladies Club, play a valuable role in fostering community and participation at Rancho Park. However, their activities should not come at the expense of all other players. In the past, when brokers hoarded tee times, regular golfers could at least rely on cancellations to secure a slot. Now, with no tee times available to cancel on Tuesdays, that safety net has vanished. This is not a matter of inconvenience but a fundamental breach of the public trust that the Golf Division is tasked with upholding.

I respectfully request that the Golf Division investigate this practice and take immediate action to limit the Ladies Club's reservations to a reasonable portion of Tuesday tee times—perhaps a set number of slots or a specific time window—allowing other golfers, including seniors, fair access to the course. Additionally, I ask for transparency on how such arrangements are approved and whether they align with the Golf Division's stated policies. Regular updates on this matter, as promised by Matthew Rudnick at the Board of Recreation and Park Commissioners meeting in August 2024, would be appreciated by the golfing community.

Thank you for your attention to this pressing concern. I look forward to a response detailing how the Golf Division will address this inequity and restore Rancho Park Golf Course as a truly public facility for all Angelenos. Please feel free to contact me at if further discussion is needed.

My name is Christine Sacani and I am a resident of the Crestwood Hills community in Kenter Canyon (Los Angeles).

In July of 2023, a resident of Crestwood Hills reached out to you about a lapse in maintenance at our beloved Crestwood Hills Park.

I was thrilled that, soon after this correspondence, action was taken and our beautiful park was re-seeded, renewed and eventually re-opened for our community to enjoy. It was thriving and felt joyous to us all, so thank you.

Unfortunately, a few months after the park's re-opening, Los Angeles was hit with heavy rains and flooding. Homes in the area were damaged and the park was deluged with heavy water and debris flow from the north. A stream surge coming from neighboring Tumbleweed Camp caused damage to the south park - creating a small gully with unstable areas, changing the topography of the landscape. The park was deemed unsafe and locks were put on all access points and gate entrances. Today, a full year (+) later, the park remains locked to the public and the Crestwood Hills Community.

This is unfathomable to me and truly painful for our tight-knit community - to no longer have this idyllic respite - especially during this trying time for the Palisades and Brentwood.

Community and camaraderie are more important than ever right now and believe it or not this park is additive to the mental health and well-being of us all. This may be hard to quantify but it is not hard to acknowledge. Crestwood Hills South Park is our meeting ground - providing a green space for social connection, relaxation and physical activity - and as such is an integral part of this perfect packet of Los Angeles.

I know you understand this - because you took the steps needed to save the park back in 2023 - so I am asking, once again, for your attention and help.

On behalf of the entire community I am urging you to not let this park go dormant again. Please, please repair the areas of concern and open this lovely and peaceful park to our community once again.
