- An RFP was released on June 17, 2024 for the operation and maintenance of the Stoney Point Ranch Equestrian Center Concession. A pre-proposal conference is scheduled for July 16, 2024 and proposals are due on September 17, 2024.

- Demolition is complete. Revised plans are going through the approval process. Upon final approval(s) from LAFD, LADBS, and BOE concessionaire will issue approved drawings to general contractor for costs including from sub-contractors.
