SUMMARY OF NEW AND CURRENT BUSINESS ITEMS September 19, 2024

Rancho Park Golf Clubhouse Renovation Update

• The project is on hold due to issues with financing. The Concessionaire remains committed to completing the project and is working on securing the financing to do so. However, is working through challenges due to: post pandemic increase in costs; the overall economic environment; and financing over \$10 million to an operator who does not own the building.

Griffith Observatory Coin-operated Telescopes

- Concessionaire gave notice to cease operations citing declining sales, the lack of people carrying coins, and key maintenance staff retiring.
- The Observatory will be purchasing the existing eighteen telescopes at \$200 each. The coin slots will be deactivated and the lens aperture left on an open setting for use by patrons at no cost.

Stoney Point Ranch Equestrian Center RFP

• Proposals were due by 2:00 p.m. on September 17, 2024 and are currently being evaluated for compliance with administrative requirements. Those that pass this review will move on to an evaluation by a qualified panel who will make a selection to be recommended to the General Manager.
