Proposed ticket price increase

The proposed ticket price increase of \$1.00 for all single ride tickets will continue to ensure that the train rides are moderately priced for families and other park visitors, and help the operator keep up with increasing costs of propane fuel, materials, staff salaries and insurance. This increase will also help the operator to continue to make improvements to the Concession.
