Alexander Hall – Waymo

Mr. Hall introduced his company's autonomous driving vehicles. Waymo has been in business since 2009. Waymo is severing San Francisco and Phoenix areas. In Los Angeles the Waymo is testing a 405 x 322 square mile area and hope to increase the service area for the public. He explained the hardware that makes the car work, from Lidar to Radar and all sort of devices to scan the road in any road condition during the day or night. Mr. Hall used a Power Point presentation and video to show how the car would react in certain situations. Mr. Hall explained how the cars Lidar was able to pick up vehicles that human eyes would normally miss, and be able to a not get in a t-bone collision when





another car runs a red light. Many of his discussion point were about all the technology. The board found all the tech very interesting. All the information can be found on Waymo's Website Waymo.com.
